
Due to the anticipated threat of the Coronavirus Disease (COVID-19) A request for an extension to allow sufficient time for interested bidders to conduct site visits, particularly as COVID-19 protocols are causing delays in travel. Therefore, this Addendum is issued to reschedule the bid submission deadline and opening for on-island and off-island bidders.

- Sealed bid submittals for this project must be submitted with **one (1) original and three (3) copies** to the Office of the Director of Procurement Services located at the former Emergency Management Office, Ascencion Drive, Building No. 1301, Capitol Hill, Saipan no later than *10:00 a.m., local time, September 01, 2021* is changed to read **no later than 10:00 a.m., local time, September 10, 2021** and must be marked **RFP21-OPD/DPW/MOT-152**.
- Bidders outside the Commonwealth must notify the Director of Procurement Services in writing, of their intent to submit a Notice of Intent to Bid in order to receive this additional seven (7) working days for the receipt of the actual bid documents. This Notice of Intent to Bid may be any mode of written communication including facsimile to (670) 664-1515 or e-mailed to sp.cabrera@dof.gov.mp but must be received no later than *10:00 a.m., local time, September 01, 2021* is changed to read **10:00 a.m., local time, September 10, 2021**.
- Bids submitted by firms outside the Commonwealth must be postmarked by the U.S. Postal Service or the official government postal service of a foreign country by *September 10, 2021* is change to read **September 10, 2021** and mailed to the Office of the Director of Procurement Services to P.O. Box 510008, C.K., Saipan, MP 96950 and the bid documents must be received at the Office of the Director of Procurement Services no later than *September 09, 2021* is changed to read **September 20, 2021**.
- Bids will be publicly opened and read at the Division of Procurement Services located at the former Emergency Management Office, Ascencion Drive, Building No. 1301, Capitol Hill, Saipan, at *10:00 a.m., local time, September 10, 2021* is changed to read **10:00 a.m., local time, September 21, 2021**. However, if no Notice of Intent to Bid are received from bidders outside the CNMI, bids will be opened at *10:00*

a.m., local time, September 01, 2021 is changed to read **10:00 a.m., local time, September 10, 2021.**

The provisions of the CNMI Procurement Regulations, NMIAC Section 70-30.3-725 and 70-30.3-730 prohibiting Gratuities, Kickbacks, and Contingent Fees shall apply.

The CNMI Government reserves the right to reject any or all bids or portions thereof, and waive any immaterial defects if to do so would be in the best interest of the CNMI government.
