

Summary of Plans and Recommendations for the Northern Islands:

Given the very limited population of the Northern Islands, there are no specific solid waste management facilities planned for the islands at this time.

However, homesteading plans and some tourism to the islands are beginning to develop. As such, one recommendation is to support "zero waste" planning and promote behaviors such as not disturbing wildlife and packing out all waste when leaving the islands.

Alternative energy solutions are also being discussed for the Northern Islands. Future feasibility studies and pilot projects on alternative energy for the islands may support the development of critical infrastructure that can further zero waste and recycling goals.

This group of partnering agencies— OPD, DPW, the Offices of the Mayors of Saipan, Tinian and Aguiguan, Rota, and the Northern Islands, BECQ, and EPA— is collectively known as the Inter-Island Solid Waste Management Taskforce.
