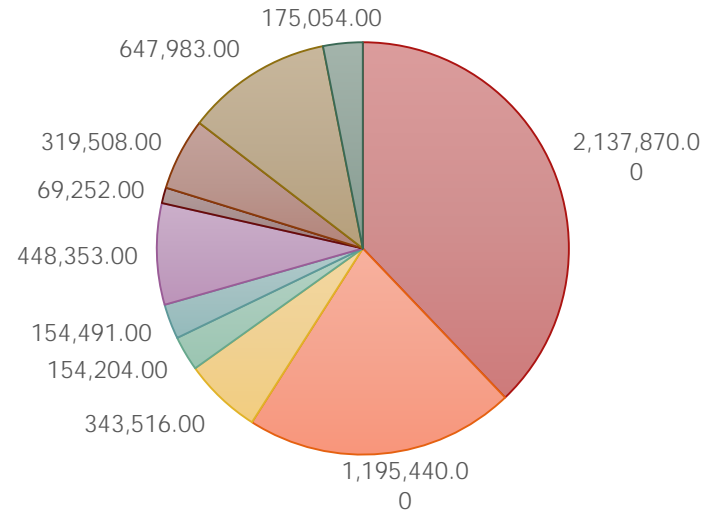

CHALLENGES & PRIORITIES....

➤ The **COVID19** Pandemic has negatively impacted the administration's ability to fully execute all services. There were 45 civil service employees that were furloughed and 64 ungraded employees that were terminated. As a result of the United States Congress approving the US Cares Act that included the residents in the US territories to qualify for the Pandemic Unemployment Assistance and the Pandemic Unemployment Assistance Compensation. Many of our local residents have qualified and availed of these opportunities. Although our people have received assistance, this pandemic has greatly hindered the governmental services that have been provided on a daily basis. With the massive reduction in force, many projects and programs were halted and postponed.
